The EXHIBITOR (hereinafter called the EXHIBITOR) hereby requests space in the RecX OUTDOOR RECREATIONAL EXPOSITION.

- **50%** of EXHIBITOR fee is **due and payable upon approval** of EXHIBITOR contract. An assigned exhibit space is not confirmed until at least 50% of deposit is received.
- EXHIBITOR fee must be **paid in full** by **January 30, 2026** for the company name to appear in the Official Expo Show Guide and for your assigned exhibitor space to be held.
- A valid **certificate of insurance** must be on file with RecX by **April 1st**.

The rules and regulations in the RecX Contract for EXHIBITOR Space and Support Services constitute a binding contract when signed by a designated company official. The EXHIBITOR agrees to abide and conform thereto. (See remainder of contract). IN WITNESS, whereof, EXHIBITOR has caused this contract to be signed by an officer of the company or person duly authorized.

CONTRACT FOR EXHIBITOR SPACE AND SUPPORT SERVICES

IN CONSIDERATION of the mutual covenants hereinafter set forth, the parties hereto contract as follows:

- A. RecX, LLC (hereinafter called RecX) will permit the EXHIBITOR to use EXHIBITOR space subject to the express conditions enumerated herein. RecX reserves the right to reject contracts for desired EXHIBITOR space and specify location of space rented. A violation by EXHIBITOR of any condition express or implied in the rules and regulations of RecX or Spence Field facilities shall authorize RecX to terminate this agreement, whereas EXHIBITOR shall immediately vacate the above-described space and forfeit, as damages, any sum of money paid to RecX.
- B. Deadline for set-up is 5 p.m. April 30 th . EXHIBITORS failing to meet the deadline will not be permitted to set up until 6 p.m. May 1 st . Exhibits shall remain intact until 3 p.m. May 3 rd . All exhibits and semi-permanent structures must be removed from show site no later than May 5 th by 5 p.m. and the EXHIBITOR space restored to the original condition. No modification to hard surface is to be made without prior written permission from RecX. Any property remaining after May 5 th at 5 p.m. shall become property of RecX. RecX will not be responsible for any items left on show site after the close of the expo. Any damage done to the expo grounds and/or another EXHIBITOR's permanent structure is the SOLE LIABILITY of the EXHIBITOR who causes such damage. Transfer of property by EXHIBITOR through gift or sale shall not release the EXHIBITOR of this covenant.
- C. In no case shall the EXHIBITOR allow other individuals or organizations to sublease or rent exhibition space.
- D. No signs, aerial pieces, or other devices shall extend above the normal height of the tents and exhibits except as approved by RecX.
- E. EXHIBITOR shall not sell t-shirts, caps, tasers, dart guns or dispense food or drink, nor sell or permit the free distributions on leased space and premises of any intoxicating liquors or malt beverages, and shall not do or permit any obnoxious or offensive activity, fraudulent sales or gifts, or any activity endangering any property of persons, nor shall EXHIBITOR undertake or allow any activity whatsoever that shall constitute a nuisance as is defined by the laws of Georgia. KNIVES AND FIREARMS MUST BE KEPT IN A LOCKED CASE. Whips are not to be sold to individuals under 18. All federal, state and local laws must be followed.
- F. All laws, rules or regulations of the state of Georgia and rules, regulations and orders issued by RecX are accepted as aforesaid as part of the agreement and shall be complied with. These rules and regulations shall set out provisions of conditions and requirements for all exhibits including all exhibits, seminars, demonstrations, vendors, etc.
- G. RecX's agreement to permit use of the space specified above shall be subject to acts of god or any condition or circumstances beyond the controls of RecX which shall prevent the carrying out of some or all of the expo. Upon the occurrence of such event, RecX shall have the right to terminate this agreement without liability of any nature.
- H. EXHIBITOR assumes the risk of weather and shall indemnify and hold RecX, Sunbelt ag Expo and the City of Moultrie, Georgia harmless from damage/loss related to weather.

It is further agreed by the parties hereto as follows:

- 1. No rights or privileges of the EXHIBITOR under this agreement shall be assigned or transferred without the prior written consent of RecX.
- 2. EXHIBITOR shall indemnify, save and hold harmless RecX, Sunbelt Ag Expo, and the City of Moultrie, Georgia, their officers, agents and successors from and against any and all claims, demands, actions or causes of actions, suits at law or inequity of any nature or character arising out of or be reason of any act or omission of the EXHIBITOR or its agents in the performance of the rights, duties and obligations of the EXHIBITOR under this agreement.
- 3. EXHIBITOR warrants that it has in effect and shall maintain for a period of this agreement for the mutual benefit of both parties a policy of public liability insurance against claims for personal injuries or death, or damages to property occurring upon, in or about the herein rented premises, in limits of not less than \$1,000,000.00 combined single limit by virtue of EXHIBITOR's authorized signature. EXHIBITOR will supply certificate of insurance (COI) naming RecX, Sunbelt Ag Expo and City of Moultrie, Georgia as additional insured.
- 4. In the event of reasons necessary to cancel or vacate, the undersigned agrees to the following: cancellation will be subject to a penalty of 50 percent of full EXHIBITOR fee — no refund on EXHIBITOR fees of 50 percent or less. If a completed reservation is canceled after December 31 st , NO REFUND WILL BE MADE.
- 5. EXHIBITOR spacing is assigned on a first come first serve basis. In order to be considered for a specific location, signed EXHIBITOR contract and 50% of EXHIBITOR fee must be received by RecX. Checks are to be made payable to RecX, LLC. Credit Cards are accepted via the Map Your Show online EXHIBITOR portal located at WWW.RECXOUTDOORS.COM.
- 6. EXHIBITOR reservation is not complete and is voidable by RecX until EXHIBITOR fee is paid in full.
- 7. No refunds will be made to EXHIBITORS who fail to exhibit at RecX without proper notification and qualification as stated above.
- 8. The EXHIBITOR shall place all parts of the exhibit within the confines of space rented and assigned. This includes aerial overhangs and projections.
- 9. The EXHIBITOR vehicles shall be parked in the designated EXHIBITOR parking lots or in one of the visitor parking lots.
- 10. Vehicle traffic, including but not limited to trucks, cars, golf carts, ATVs, UTVs, lawnmowers or any type of mobile or riding equipment, is prohibited within the exhibition area during the three days of the expo, May 1st , 2nd , and 3rd.
- 11. The EXHIBITOR shall confine its educational efforts (registration, literature, public address systems, give-away items, etc.) to its assigned exhibit space. No literature is to be passed out in the parking area or show entrances. Public address systems must be used within tents or exhibit areas and not directed to the public in general. The volume must be within reasonable levels, to be determined by RecX Management and must not interfere with other EXHIBITORS. NO RAFFLES allowed which require a monetary fee to participate.
- 12. This contract is terminable only at the discretion of the RecX.
- 13. In the event RecX Outdoor Recreational Exposition is canceled, all EXHIBITOR fees are subject to an administrative fee of 20%.
